PRIVACY POLICY OF "ATELIER SERAFIMOV ARCHITECTS" OOD IN THE PROCESSING OF PERSONAL DATA

1. Introduction

One of the main concerns of "ATELIER SERAFIMOV ARCHITECTS" OOD is the security of the personal data of the natural persons - our clients and partners, by taking the necessary measures to bring our activities in line with the best practices and legal requirements for protection of personal data and its confidentiality.

This Policy aims at explaining why we collect and how we treat the information and personal data you provide. Please be aware of this privacy policy before you become our client and / or use our site as it provides information on how we process your personal data and how we will use "cookies". Processing your personal data will be executed as described in this Policy.

By presenting this Policy, we aim to clarify what information we collect about you, why and how we do it, what your rights are under the Personal Data Protection Act (PDPA) and the General Data Protection Regulation (EU Regulation) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016, also known as the Regulation or GDPR.

2. Information about "ATELIER SERAFIMOV ARCHITECTS" OOD as a Personal Data Administrator

3. Why is your consent necessary

4. Policy Purpose

- Provides protection against the risks of data breaches.

5. Information required

- Records from correspondence via www.asa-bg.com, e-mail, telephone or other methods;
- Your answers to questionnaires or surveys for our clients;
- Details of your visits to www.asa-bg.com, including, but not limited to, traffic data and other communications data.

6. Protecting your personal data

Your personal data is protected not only by our actions and the high standards of "ATELIER SERAFIMOV ARCHITECTS" OOD, they are also protected by the Personal Data Protection Act and the Regulation. According to the law, we can process your personal data only if there is a reason to do so, and these reasons may be one of the following:

7. Consent

Unless it is necessary for a reason admissible in GDPR, "ATELIER SERAFIMOV ARCHITECTS" OOD will always request the explicit consent of the data subject to collect and process the data. In the case of children under the age of 18 or persons under guardianship, the consent of the parent / guardian / guardian will be sought. Entities may exercise their rights under GDPR (request for access to their personal data, correction, limitation of processing, denial of automatic profiling, deletion) in a manner established and communicated to them, within the framework of the law, free of charge and within 30 / thirty / days after filing the request.

8. The vital interests of the data subject

Where personal data are necessary to protect the vital interests of the data subject or another individual, this may be used as the legal basis for the processing.

9. Confidentiality right protection

"ATELIER SERAFIMOV ARCHITECTS" OOD has adopted the principle of confidentiality in designing (innovations) and will ensure that the identification and planning of all new or significant changes in the processes in which personal data are collected or processed will be subject to due consideration of the issues related to confidentiality, including the completion of one or more impact assessments on data protection.

10. Personal data international transfer

"ATELIER SERAFIMOV ARCHITECTS" OOD transfers personal data to other countries, including those outside the European Union. The transmission of personal data processed or intended to be processed after the transfer to a third country or to an international organization outside the EU is carried out by "ATELIER SERAFIMOV ARCHITECTS" OOD only under the terms of the General Regulation on Data Protection - Regulation (EC) 2016 / 679, subject to the conditions laid down in Chapter V of the Regulation.

11. Your data processing principles

We adhere to the following principles when processing your personal information:

- Principle of legality, good faith and transparency;
- Target restriction principle;
- The principle of minimizing data;
- Principle of accuracy;
- Restriction of storage principle;
- Principle of loyalty and confidentiality.
